

The Meeting of the Anti-Ragging Committee for the academic year 2021-2022 held on 07.03.2022 at 2:00 p.m. in Smart Hall







Discussion Points:






MINUTES OF MEETING (2021-2022) ODD SEMESTER


Discussion Points:
